AGENDA

Upon motion by Commissioner Hermann Jr., seconded by Commissioner Ahmann-Maples, all members voting in favor, the agenda was approved as amended by moving the "Comprehensive Plan Update" to first item for discussion under "Old Business".

OLD BUSINESS

Comprehensive Plan Update

WSB Representative, Roxy Franta, stated that a draft copy of the City's Comprehensive Plan has been sent to the Metropolitan Council and a message has already been sent back to the City of Mahtomedi from them with only one small suggestion. She stated that the Met Council has requested the use of Mahtomedi's draft plan for other cities to use as an example.

In reviewing the "Sustainability" section of the Comprehensive Plan, Commissioner Byrd had a few suggestions to add to the draft regarding the University of Minnesota students course SUST 4004 study. Representative Franta requested she shorten her verbiage.

Council member Ledermann took this time to introduce himself and gave a brief history on his background.

RITE of Spring

After much discussion, it was agreed by consensus that the city should give away Hack Berry, Plum and Red Pine seedlings at this year's event. Commissioner Ahmann-Maples ordered the trees from the Washington County Conservation District during the meeting.

It was agreed by consensus that this year's event will focus on these four things:

- Energy
- Water
- Composting
- Bee Keeping / Chicken Keeping

Conservation Minnesota Community Coordinator, Julie Drennen, stated that she will create a rough table and send it to commission members for their input.

University of Minnesota Students Sustainability Case Study

Commissioner Byrd stated that the students will need the B3 Benchmark information for their class. Administrator Neilson indicated that he would get them the information that they will need.

Upon a request for those commission members who would be willing to be interviewed by the students, Commissioner Hermann Jr. volunteered regarding "water"; Commissioner Ahmann-Maples for "bike/walk"; Commissioner Byrd for "Partners in Energy"; and Commissioner Chevalier for "healthy food".
