**NOTICE OF PUBLIC HEARING TO CONSIDER ADOPTION OF PARKING RESTRICTIONS ON CERTAIN CITY  
STREETS**

**NOTICE IS HEREBY GIVEN** that on Tuesday, May 4, 2021, at 7:00 p.m. the City of Mahtomedi (“City”) will hold a public hearing to solicit input from members of the public related to the potential imposition of parking restrictions on the following city streets:

**A. NO PARKING ON EITHER SIDE OF THE STREET:**

1. Summit Ave. between Hickory St. and Juniper St.
2. Kale St. from Mahtomedi Ave. to Summit Ave.
3. Arbor Ave. between Juniper St. & Locust St.
4. Neville Ave.
5. Rose St. from Mahtomedi Ave. to Park Ave.
6. Tip Top Ln.
7. Doover Ln.
8. Halcyon Ln.
9. Park Ave. from Spruce St. to Quail St.
10. Spruce St. from Mahtomedi Ave. to Park Ave.
11. Park Place
12. Neptune St. west of Mahtomedi Ave. from West of the driveway of 25 Neptune East to 50 Ft. East of Pine St.
13. Old Wildwood Road
14. All alleys within the City

**B. NO PARKING ON ONE SIDE OF STREET:**

1. Birch St.: No parking on the North side of the street
2. Fir St.: No parking on the North side of the street
3. Summit between Juniper & Locust: No parking on the East side of the street
4. Arbor between Juniper & Hickory: No parking on the East side of the street
5. Oak. St.: No parking on the West side of the street
6. Crocus St.: No parking on the North side of the street
7. Tamarack St. West of Mahtomedi Ave.: No parking on the North side of the street
8. Wildwood Beach Road from Doover Lane to Ash St
9. Ash Street from Wildwood Beach Road to Park Ave
10. Park Avenue from Ash Street to Locust St
11. Hickory Street from Park Avenue to Park Avenue
12. Locust Street from Park Avenue to Summit Avenue
13. Summit Avenue from Locust Street to Maple Street
14. Maple Street from Summit Avenue to Mahtomedi Avenue
15. Wildwood Beach Road from Birchwood Road to Doover Lane
